

RELEASE, HOLD HARMLESS AND INDEMNIFICATION BY RIDER AND PASSENGER

The undersigned (on my own behalf and on behalf of my heirs, personal representatives, successors and assigns), for and in consideration of the opportunity to participate in the event sanctioned by Cruisin the Blues Highway (CBH) - Illinois, and for other considerations, the receipt and adequacy of which are hereby acknowledged and thereby represents to and agrees with CBH - Illinois, its directors, officers, members, agents and contractors as follows:

The undersigned acknowledges that motorcycling is an activity that involves the risk of personal injury to participants and their property, and the undersigned accepts and assumes the risks inherent to participating in a motorcycling event.

The undersigned, if a rider (the operator of a motorcycle) in a CBH - Illinois sanctioned event, has a valid motorcycle operator's license for the type and class of motorcycle being operated by the undersigned in the CBH - Illinois sanctioned event and has the requisite motorcycle operating experience to safely participate in the event.

The undersigned, if a rider in a CBH - Illinois sanctioned event, has valid motorcycle operator's liability insurance as required by applicable laws for the motorcycle being operated by the undersigned in the CBH - Illinois, sanctioned event.

The undersigned acknowledges that neither CBH - Illinois, nor its directors, officers, members, agents or contractors are authorized to give briefings, directions, instructions, or signals that shall be binding on the undersigned and that any briefings, directions, instructions or signals given to the undersigned by CBH - Illinois, its directors, officers, members agents or contractor or any other participant in the CBH - Illinois event, are gratuitous and shall be followed by the undersigned at the undersigned's sole discretion and election, and if followed by the undersigned are done so at the sole risk of the undersigned.

The undersigned shall be solely liable for any injury to persons or property resulting from the actions or omissions of the undersigned in the CBH - Illinois sanctioned event.

The undersigned releases CBH - Illinois, its directors, officers, members and guests from any and all liability whatsoever for any injury to the undersigned or any participant or the property of the undersigned or the property of any participant in a CBH - Illinois sanctioned event whether or not any such injury or damage results from the negligence of a released party (except willful neglect), and shall be responsible solely to the person causing any injury to the undersigned or any participant or the property of the undersigned or any participant in the CBH - Illinois sanctioned event.

The undersigned shall hold CBH - Illinois, the directors, officers, members, agents, sponsors, supporters, friends, The Blues Foundation and contractors, harmless from and hereby indemnifies them against any and all liability whatsoever for any injury to the undersigned or any other person or the property of the undersigned or any other person in connection with the CBH - Illinois, sanctioned event resulting from the actions or omission of the undersigned.
